GRACEFULLY AGING AT NBCC

As NBCC enters its 19th year, we continue to look at our demographics. Paralleling other mental health professionals, NCCs are mostly professional women (74 percent). We also tend to mirror U.S. geographic apportionment with about 80 percent of NCCs living in the Eastern and Central time zones. Our diversity is more pronounced than most graduate level professions but less diverse than the population of the country as a whole. Looking back at that first figure, female population, gives us a start at projecting numbers of National Certified Counselors we can expect to see in the next two decades. Here is some of our thinking, which allows us to project budget, space, staffing, and projects for NBCC and affiliates.

Professionals retire fully from careers in increasing numbers between 55 and 65 years of age. Women retire a bit earlier than men. While we have no clear way of knowing our patterns, we expect counselors who are salaried through governmental employment to retire earlier than self-employed individuals. We also expect an increase in part-time, later-age practice.

NBCC has two quite influential factors to keep in mind as we project growth. First, we were formed in 1982 with 16,000 early entrants to our ranks. Since most master's level counselors at that time began to practice in their 30s, it is not surprising that almost half of all NCCs are over 50

years of age. This would be of great concern to NBCC and the clients we serve if our applicant rate was dwindling. Not only do we receive more applicants each year, but NBCC's annual renewal rate has been higher than 95 percent for years. This is the reason that from 1990 to 2000, the

number of active NCCs increased from 13,500 to the more than 31,000 today.

But should we expect that increase to continue? The second most influential set of factors on our future is the effect of the "Baby Boomer" retirement, "Boomer Echo" population increase, and counselors' changing emphases in practice. So we can only guess the future but we do so conservatively and with a hard look at our past data.

We think that NCCs will increase in numbers through the next eight years, but the 2,500 increase in NCCs per year will lessen by 2008. At that time, retirement *may* cancel growth to a steady certificant base of about 40,000–45,000 for about five years (2008–2013). Then we expect the aging effect to diminish, as a more normal distribution of ages will mark our demographics.

The "Boomer Echo" (and more school-aged children) will bring more jobs for school counselors and our numbers will increase in that area of practice. This could affect overall numbers positively. We cannot predict what effect the Internet and managed care mergers will have on our largest practice group—mental health counselors. Further, we still do not have good data regarding the effect that our aging U.S. population will have upon the "full retirement" and dropping of certification by our NCCs. We expect more and more of us to continue part-time practice in later years.

The key to our growth success has been the constant stream of new graduates becoming certified. High recertification figures and lower average ages of graduates have paired to allow us to predict a solid future and continue to keep costs to certificants low.

DANCE THERAPY RECOGNIZED AS COUNSELING SPECIALTY

The NBCC and the American **Dance Therapy Association** (ADTA) are pleased to announce recognition of dance therapy as a specialty of counseling. The two organizations have worked toward this goal since 1995. As part of this process, NBCC representatives reviewed dance therapy graduate programs, registry requirements and procedures, dance therapy research and publications, and ADTA documents and records. A comparison of ADTA dance therapy graduate program requirements to the Council for Accreditation of Counseling and Related **Educational Programs (CACREP)** requirements for counseling programs found dance therapy graduate programs to be similar and comparable to graduate programs in counseling.

Dance therapy (also called dance/movement therapy) is the psychotherapeutic use of movement as a process to further the emotional, cognitive, social, and physical integration of the individual. Dance therapists are employed in schools, psychiatric treatment centers, rehabilitation settings, private practice, correctional facilities, day care centers, and developmental centers throughout the United States, Canada, Europe, South Africa, Asia, the Middle East, Africa, and Australia. They work with people of all ages individually and in groups. Dance therapists also act as consultants and engage in research.

Dance therapists work with clients on issues such as depression, anxiety, eating disorders, autism, substance abuse, Alzheimer's disease, cancer, AIDS, post-traumatic stress disorder, attention-deficit disorders and learning disabilities, and abuse trauma. Dance therapy is particularly useful to clients who are unable to work with, or who have minimal success with, verbal modalities. For example, dance therapy offers adolescents and adults an active, body-centered approach to address issues of emotional expression, body image, boundaries, and behavioral modulation and control.

The agreement between NBCC and ADTA designated the Academy of Dance Therapists Registered (ADTR) credential as the appropriate counseling specialty credential in dance/ movement therapy. The ADTR is the advanced credential offered by ADTA. It signifies readiness to teach, supervise, and work in private practice. All counselors who have obtained the ADTR level of certification and who hold a minimum of a master's degree in a mental health profession are eligible to apply for the NCC credential. In addition. the ADTA offers alternate route training for master's level counselors with dance and movement experience who are interested in becoming dance therapists.

This collaborative effort will benefit consumers by making another innovative approach for treatment more accessible. It is important to counselors as well since it opens many opportunities for joint research, publications, and educational opportunities. Susan Eubanks, NBCC associate executive director for professional affairs, commented, "This collaboration provides an additional avenue for counselors in practice. In addition, we are unifying our professions because we are counselors first with a variety of specialties and settings from which to choose. Such choices allow us to provide better care and to maximize benefits to consumers and clients."

NEW RECERTIFICATION SCHEDULE

By the time this newsletter hits your mailbox, NBCC will have begun a new schedule of recertification. You should receive your recertification form shortly before your birth month. It will be green, and it will bill you for the upcoming year. In addition, it will tell you whether or not you have been selected for the mandatory audit. If you are selected, you will need to send copies of your continuing education documentation for 100 hours from the last five or so years along with the form and fee payment. If you are not selected, you will need to send the form and fee payment but no documentation. Even if your fee owed is zero, you must still return the form in order to be recertified. 





Recertification News

DO YOU HAVE YOUR CONTINUING EDUCATION FOLDER?

All NCCs should have a Continuing Education File folder issued at the time of certification. If you never received one or if you have lost yours, please fax a request for one to 336-547-0017. This folder contains all the regulations covering recertification and continuing education for NCCs. It is important that you have it in order to be prepared for recertification when your expiration date arrives.

FOR LAPSED NCCS

If you know a former NCC who might be interested in reactivating the credential, please have him or her contact the NBCC Recertification Department. Reinstatement is a relatively simple process of signing the one-page form, paying the fees, and submitting continuing education or a recent passing NCE score. The examination is not required if the counselor can document 100 hours of continuing education since the last date of certification or recertification.

TAKING NON-APPROVED CONTINUING EDUCATION
